Guidelines:

1. Fill out the application below and attach **TYPED** responses to the questions on the back of the form. The application must be no more than **THREE Typed pages on 8 ½ X 11 paper, with no less than a 10 point font.**
2. Each candidate must be a representative of a youth organization participating in the Butler County Fair.
3. If you won in a department last year, you must run for a new department this year.
4. Each contestant must be 16 to 18 years of age as of January 1st of the current year. Must not be married, or have been married, given birth, or fathered a child.
5. Each contestant must **submit one letter of recommendation** with their application.
6. Every crowned Department Queen is required to compete in or attend the Butler County Junior Fair Queen Contest.
7. Read and submit the Jr. Fair Royal Court Contract. If you plan to run for Fair King or Fair Queen, this contract must be signed and turned in with your application.
8. Scoring will be done on the following basis.
